Pension Increase 2022

I write to inform you of this year's pension increase and seek your assistance in passing on the message to your members for their information.

The Chief Executive has made notices to declare and specify a 2.4% increase in pensions and dependant pensions with effect from 1 April 2022. Such arrangement applies to all pensions and dependant pensions in payment on or before 1 April 2022, except for pensions paid to pensioners who have not yet reached the normal retirement age and therefore are not entitled to any pension increase. pension increase is, as prescribed by law, determined according to the percentage increase in the average monthly Consumer Price Index (A) for financial year 2021-22 over that of 2020-21. The Director of Accounting Services will notify the relevant pensioners and dependants of the pension increase which will be reflected in the pension payments from June 2022 onwards.
