Appointment Arrangement of New Mobile Application for Civil Service Chinese Medicine Clinics (CSCMCs)

I write to inform you that civil service eligible persons (CSEPs) can make use of the new dedicated page under "18 CM Clinics" mobile application ("the App") of the Hospital Authority to book CSCMCs' services with effect from 21 December 2022. CSEPs may download the App and enter "CSCMCs Service" dedicated page via the home page of the App to make appointments on the same day and the next working day for general consultation and acupuncture services. The App only allows appointments for episodic diseases and is not applicable to follow-up appointments.

The new dedicated page for CSCMCs provides CSEPs with a simple, easy-to-use and informative mobile platform. It facilitates CSEPs to access information on CSCMCs (including availability of discs at each clinic) anytime and anywhere. Apart from appointment booking services, the App supports cancellation of appointments made via the App and provides users with real-time information on medicine collection status. Appointment Arrangement of New Mobile Application for Civil Service Chinese Medicine Clinics (CSCMCs)

With effect from **21 December 2022**, civil service eligible persons (CSEPs) can make use of the new dedicated page under "18 CM Clinics" mobile application ("the App") of the Hospital Authority to book CSCMCs' services.

Appointment booking of CSCMCs' services through the App

- 2. CSEPs may download the App and enter "CSCMCs Service" dedicated page via the home page of the App to make appointments on the same day and the next working day for general consultation and acupuncture services. The App only allows appointments for episodic diseases and is not applicable to follow-up appointments.
- 3. CSEPs who have previously registered for services at any one of the 18 Chinese Medicine Clinics cum Training and Research Centres or CSCMCs can use the App for appointment booking, separate registration for the App is not required. New appointment slots are released for booking through the App every working day at the time when the clinics start to provide service. As for CSEPs who are first-time users of services of the above clinics, please make appointment through telephone booking hotline for the first time, the booking function of the App will then be activated after attending the appointment.
- 4. The new dedicated page for CSCMCs provides CSEPs with a simple, easy-to-use and informative mobile platform. It facilitates CSEPs to access information on CSCMCs (including availability of discs at each clinic) anytime and anywhere. Apart from appointment booking services, the App supports cancellation of appointments made via the App and provides users with real-time information on medicine collection status.
- 5. Upon commencement of the above-mentioned dedicated page for CSCMCs, the telephone booking hotline of CSCMCs continues to provide booking and enquiry services.
