HKFSCSA Circular to Members (No. 1/2023)

Information on the Civil Service Chinese Medicine Clinic (CSCMC)

Purpose

The purpose of this circular is for the **HKFSCSA** (the Association) to help disseminate (as advised by the SCS memo dated 14 March 2023) the information conveyed to the Association by the Secretary for the Civil Service (SCS) on "Setting up the third Civil Service Chinese Medicine Clinic (CSCMC)". (This memo also noted that the SCS had informed the Civil Service Eligible Persons (CSEPs) of the relevant details on the first two CSCMCs through bureaux/departments vide their memo dated 25 Feb 2020.)

An abstract of the relevant Government Notices dated 10 March 2023 (on the third Clinic) and 25 February 2020 (on the first two Clinics) respectively is consolidated below for your ease of reference.

Pilot Scheme for Provision of Chinese Medicine Services to CSEPs

On 14 March 2023 the Association was informed by the Secretary for the Civil Service on the setting up of the third Civil Service Chinese Medicine Clinic (CSCMC) besides the earlier two CSCMCs operational since 2 March 2020. The 3 CSCMCs are for the provision of free general consultation and acupuncture services for treatment services for the exclusive use of **Civil Service Eligible Persons (CSEPs)** including retired civil servants (living in HK and in receipt of a pension or an annual allowance and their eligible dependants living in HK).

Other details are summarised below:

- This Pilot Scheme for Provision of Chinese Medicine Services is only covered by the 3 present CSCMCs for CSEPs, i.e. Eastern District, Tsuen Wan and Northern District.
- The HKFSCSA membership card can be used for the identification of CSEPs.
