公務員及合資格人士牙科服務深圳試點計劃

政府將在 2025 年第一季推出「公務員及合資格人士牙科服務深圳試點計劃」(試點計劃),安排約二千名正在輪候衞生署牙科服務的公務員及合資格人士到深圳新風和睦家醫院(和睦家醫院)接受指定牙科服務。本便箋載列試點計劃的詳情,請各局/部門將本便箋內容告知所有合資格享用公務員牙科福利的人員。

運作安排

- 2. 試點計劃為期一年,由 2025 年 2 月 17 日至 2026 年 2 月 16 日。參加試點計劃的人士可於和睦家醫院接受指定的牙科服務,包括口腔影像(X光)檢查及洗牙服務。
- 3. 参加試點計劃的公務員及合資格人士必須年滿 18 歲。衞生署會先邀請新症人士「參加試點計劃。倘有尚餘名額,衞生署會邀請其他正在輪候牙科服務的舊症人士參加。參加試點計劃屬自願性質,並不會影響公務員及合資格人士日後享用衞生署的牙科服務。

¹ 新症人士指由 2024 年 1 月起使用電子登記表格登記輪候政府牙科服務,而自登記後未曾於政府牙科診所接受首次全面牙科檢查的公務員及合資格人士。

- 6. 参加者會在接受牙科服務後翌日收到衞生署的電話短訊及電郵,邀請其填交服務意見問卷。有關問卷不會索取個人資料, 所收集的意見和資料亦只會作分析試點計劃成效之用。

跟進安排

- 7. 在完成試點計劃下的牙科服務後,和睦家醫院會向參加者提供診症報告。參加者可透過「醫健通」流動應用程式內的「個人資料夾」功能³,上載及存放和睦家醫院提供的診症報告到個人健康戶口,以便衞生署閱覽並為有需要的個案安排約期到政府牙科診所跟進。為此,參加者請先登記成為「醫健通」用戶⁴。其他沒有跟進需要的參加者亦會獲衞生署安排約期,並於約期前約三個月收到衞生署短訊通知。
- 8. 假如公務員及合資格人士於預約接受試點計劃服務後,最終沒有接受服務,亦沒有於約期前通知和睦家醫院取消預約,有關人士將不會獲邀參與本地的牙科服務(洗牙)先導計劃。他們輪候政府牙科診所服務的安排請參閱有關附件⁵。

現職公務員參加試點計劃

9. 現職公務員如選擇參加試點計劃,須自行安排於假日或非上班期間參加。《公務員事務規例》第 904 條有關短暫離開工作崗位以接受治療、檢驗或診症服務的安排並不適用。





Pilot Scheme on Dental Services for Civil Service Eligible Persons in Shenzhen

The Government will launch the Pilot Scheme on Dental Services for Civil Service Eligible Persons in Shenzhen (PDSSZ) in the first quarter of 2025 to arrange about 2 000 Civil Service Eligible Persons (CSEPs), who are waiting for dental services of the Department of Health (DH), to receive designated dental services at the Shenzhen New Frontier United Family Hospital (NFUFH). Bureaux/departments are requested to bring this memo, which sets out the details about the PDSSZ, to the attention of all staff who are eligible for civil service dental benefits.

Operational Arrangements

- 2. The PDSSZ will last for one year from 17 February 2025 to 16 February 2026. Participants of the PDSSZ can receive designated dental services, including oral imaging (X-ray) check and dental scaling services, at the NFUFH.
- 3. CSEPs participating in the PDSSZ must have reached 18 years of age. DH will first invite new consultation cases 1 to participate in the PDSSZ. Subject to availability of quotas, old consultation cases who are waiting for dental services would also be invited. Participation in the PDSSZ is voluntary and will not affect CSEPs' entitlement to DH's dental services in future.
- 4. DH will, starting from January 2025, invite CSEPs in batches to complete the Expression of Interest (EOI) Form for the PDSSZ. The invitation message will be sent through Short Message Service (SMS) "#DH-CLINICS" and email "cims2_notification@dh.gov.hk". The invited persons have to complete and return the EOI Form to express their interest in participation within two weeks.

¹ New consultation cases refer to CSEPs who have registered by e-Registration Form from January 2024 onwards for queuing for government dental services but have not received their first comprehensive dental check-up at a Government Dental Clinic (GDC) since registration.

- 5. DH will, starting from 17 February 2025, issue formal invitations for participation in batches through SMS and email to CSEPs who have indicated their willingness to participate in the PDSSZ. The invited persons have to make an appointment via the service hotline (operating hours from 9:00 a.m. to 6:00 p.m. daily) of the NFUFH within one month upon receipt of the invitation, and receive dental services within two months from the date of receiving the invitation. The NFUFH provides dental services from 9:00 a.m. to 5:30 p.m., Monday through Sunday².
- 6. The participants will, on the following day upon receipt of dental services, receive an SMS and an email from DH inviting them to fill in a service opinion survey. The survey will not collect any personal information, and all opinions and information collected will only serve the purpose of analysing the effectiveness of the PDSSZ.

Follow-up Arrangements

- 7. After completing dental services under the PDSSZ, NFUFH will provide participants with a medical report. Participants can upload and deposit the relevant medical report into their eHealth personal accounts through the "Personal Folder" function³ of the "eHealth" mobile application, so that DH can access and, for cases in need, schedule follow-up appointments at GDCs. In this regard, participants are advised to register as "eHealth" users⁴. For other participants who do not have follow-up needs, DH will also schedule appointments for them at GDCs and notify them through SMS about three months prior to the appointments.
- 8. If a CSEP had made an appointment to receive services under the PDSSZ but did not receive such services eventually without notifying the NFUFH in advance to cancel the appointment, the person concerned would not be invited to join the local Pilot Scheme on Dental Services (Dental Scaling). Please refer to the relevant Annex⁵ regarding the arrangement for awaiting dental services at GDCs.

Serving Civil Servants Participating in PDSSZ

9. Serving civil servants who choose to participate in the PDSSZ are required to make their own arrangement for receiving services during holidays or non-duty hours. The arrangement on time-off from duty for treatment, examination or consultation stipulated in Civil Service Regulation 904 is not applicable.





Pilot Scheme on Dental Services for Civil Service Eligible Persons in Shenzhen Flow Chart of Booking Dental Appointment






