公務員及合資格人士牙科服務(洗牙)先導計劃第二期

政府於 2023 年 7 月推出為期 18 個月的「公務員及合資格人士牙科服務 (洗牙) 先導計劃」 (下稱「先導計劃第一期」),透過善用私營牙科市場資源紓緩公務員及合資格人士輪候牙科服務時間過長的情況。先導計劃第一期將於 2025 年 1 月 31 日結束。經檢視計劃的成效後,我們決定延長計劃的服務期 18 個月,由 2025 年 2 月 1 日起至 2026 年 7 月 31 日止(下稱「先導計劃第二期」)。本便箋載列先導計劃第二期的詳情,請各局/部門將本便箋內容告知所有合資格享用公務員牙科福利的人員。

運作安排

一般而言,13 歲或以上的公務員及合資格人士會獲邀參加。獲邀人士包括舊症人士(即過往曾使用政府牙科服務,且沒有嚴重口腔病史,並已獲/正等候安排在政府牙科診所接受定期檢查或跟進治療的人士);以及新症人士(即已登記並正在輪候政府牙科新症約期的人士)。

3. 参與先導計劃第二期屬自願性質,並不會影響公務員及合 資格人士日後享用衞生署的牙科服務。參加者會在接受洗牙服務 後翌日收到衞生署的電話短訊,邀請其填交服務意見問卷。有關 問卷不會索取個人資料,所收集的意見和資料亦只會作分析先導 計劃第二期成效之用。

跟進安排

- 5. 如私營牙科診所臨床人員在洗牙過程中發現參與先導計劃 第二期的舊症人士有牙齒問題需要跟進,會透過衞生署指定的電 腦系統紀錄有關情況,以便衞生署作出跟進,有關舊症人士會收 到衞生署短訊通知相關跟進安排。至於新症人士,他們會於政府 牙科診所首次就診時獲安排詳細口腔及牙齒檢查。如公務員及合 資格人士有緊急口腔問題,他們可於服務時間到政府牙科診所尋 求急症服務。
- 6. 假如公務員及合資格人士於預約接受先導計劃第二期服務後,最終沒有接受服務,亦沒有於約期前取消預約,有關人士一般不再符合先導計劃第二期的參加資格。他們輪候政府牙科診所服務的安排請參閱附件二。



Phase 2 of Pilot Scheme on Dental Services (Dental Scaling) for Civil Service Eligible Persons

The Government launched the 18-month Pilot Scheme on Dental Services (Dental Scaling) for Civil Service Eligible Persons (CSEPs) (hereafter "PDS Phase 1") in July 2023 to alleviate the situation where CSEPs had to wait a long time for dental services by making good use of the resources in the private dental sector. The PDS Phase 1 will end on 31 January 2025. After reviewing the effectiveness of the scheme, we have decided to extend its service period for 18 months from 1 February 2025 to 31 July 2026 (hereafter "PDS Phase 2"). This memo sets out the details about the PDS Phase 2. Bureaux/departments are requested to bring this memo to the attention of all staff who are eligible for civil service dental benefits.

Operational Arrangements

2. The PDS Phase 2 will continue to be implemented in the form of public-private partnership, with the appointment arrangement similar to that of the PDS Phase 1. Starting from early February 2025, the Department of Health (DH) will invite suitable CSEPs¹ (invited persons) to participate in the PDS Phase 2 by batches through Short Message Service (SMS) under the name of "#DH-CLINICS". If the invited persons agree to participate, they should, within one month upon receipt of the invitation SMS, contact and make an appointment for dental scaling services with one of the designated private dental clinics (PDCs) under the PDS Phase 2 on their own. To ensure proper utilisation of the dental scaling service quotas, they are required to complete the dental scaling within three months from the date of receiving the invitation SMS.

In general, CSEPs aged 13 or above will be invited. Invited persons include old consultation cases (Old Cons) (i.e. those who have previously received government dental services, have no history of serious oral diseases, and have been or are being arranged a recall or a follow-up appointment at government dental clinics (GDCs)); and new consultation cases (New Cons) (i.e. those who have registered and are waiting for government new dental consultation appointments).

3. Participation in the PDS Phase 2 is voluntary and will not affect CSEPs' entitlement to DH's dental services in future. The participants will, on the following day upon receipt of dental scaling services, receive an SMS from DH inviting them to fill in a service opinion survey. The survey will not collect any personal information, and all opinions and information collected will only serve the purpose of analysing the effectiveness of the PDS Phase 2.

Follow-up Arrangements

- 4. DH will schedule appointments at GDCs for participants who have received services under the PDS Phase 2, and will notify them through SMS about three months prior to the appointments.
- 5. For Old Cons participants of the PDS Phase 2, if the clinical staff of PDCs, during the dental scaling procedure, identify any dental problems with follow-up needs, they will record the problem(s) in the designated computer system of DH for follow-up by DH. These Old Cons participants will receive notifications through SMS from DH regarding the relevant follow-up arrangements. As to New Cons, they will receive a detailed oral and dental check-up during their first appointment at GDCs. CSEPs who have acute oral problems may seek emergency service from GDCs during service hours.
- 6. If a CSEP had made an appointment to receive services under the PDS Phase 2 but did not receive such services eventually without cancelling the appointment in advance, that person would generally no longer be eligible for the PDS Phase 2. Please refer to Annex 2 regarding the arrangement for such cases to wait for the services at GDCs.




