### **Revision of Charges for Dentures and Dental Appliances for Civil Service Eligible Persons**

*(Note : Distribution of this Circular Memorandum is  
Scale A. It should be read by all officers. A Chinese

This Circular Memorandum announces the revision of charges for dentures and dental appliances for persons eligible for civil service medical and dental benefits as defined in Civil Service Regulation (“CSR”) 900 (hereafter referred to as “CSEPs”).

#### **Revision of charges for dentures and dental appliances for CSEPs**

2. The charges for dentures and dental appliances under CSR 950 have been reviewed and will be revised with effect from 31 March 2025. The new charges are set out at the attached Amendment Sheets No. 11(a)/2025 and 11(b)/2025 for CSR Annex 6.2. Under the new charges, CSR 952(1), which laid down the charging method concerning dentures and dental appliances made of different materials that is no longer applicable, is deleted. The attached Amendment Sheet No. 12/2025 should replace the existing page of the CSRs. CSB Circular Memorandum No. 6/2003 should be superseded.

3. The revised charges will apply to courses of treatment which start on or after 31 March 2025. CSEPs who have started treatment before this date will continue to pay the old rates in respect of that particular course of treatment.

## CHAPTER VI - MEDICAL AND DENTAL FACILITIES

952 (1) (Deleted)

- (2) Repairs in respect of fractures to new or remodelled dentures within six months of fitting will be done free of charge if the dentist is of the opinion that the fractures are due to no fault of the patient.
- (3) These charges may be waived or reduced where hardship is involved and the dentures and dental appliances would, in similar circumstances, have been supplied to members of the public.

953 An officer and his family who wish to have full dental treatment before going on vacation leave overseas should request a dental examination not later than twelve months before their expected date of departure.

(b) **Outside Hong Kong**

- 954
- (1) An officer is not eligible for reimbursement of expenses for any dental examination or treatment obtained anywhere outside Hong Kong, either for himself or his family (except as provided under para. (2) below).
  - (2) Provided he is satisfied that the amount to be reimbursed is for emergency dental treatment and that the fees are reasonable, the Director of Health may approve reimbursement of dental expenses incurred by an officer while on duty outside Hong Kong.
  - (3) All claims for reimbursement of expenses must be supported by receipted bills and should be forwarded to the Director of Health for approval.

本通函公布，根據《公務員事務規例》第 900 條所載定義符合資格享有公務員醫療及牙科福利人士（下稱「公務員及合資格人士」）的假牙和口腔裝置的收費會作出修訂。

#### 假牙和口腔裝置的修訂收費

2. 《公務員事務規例》第 950 條規定的假牙和口腔裝置的收費經檢討後將作出修訂，並由二零二五年三月三十一日起生效。各項新收費載於《公務員事務規例》附件 6.2 的修訂散頁第 11(a)/2025 號及第 11(b)/2025 號。第 952(1) 條載列以不同物質製造的假牙及口腔裝置的收費方法在新收費安排下不再適用並予刪除，夾附的修訂散頁第 12/2025 號將取代《公務員事務規例》的現有相關頁次。公務員事務局通函第 6/2003 號現予取消。

3. 新收費將適用於二零二五年三月三十一日或之後開始的療程，至於在該日之前已開始療程的公務員及合資格人士，會繼續按舊收費支付該療程的費用。

- (2) 如果新假牙托或改樣假牙在鑲配後六個月內崩裂，而牙醫認為這並非由於病人的過失所致，則可獲免費修補。
- (3) 這些假牙及口腔裝置的費用，如屬一般市民在經濟有困難時可獲減免的，則公務員亦可在同樣情況下，獲得減免。

### 第 953 條

公務員及家屬如打算在放取例假前往香港以外地方之前接受徹底的牙科治療，必須在預計離港日期最少12個月前，預約接受牙科檢查。

#### (b) 在香港以外地方接受牙科診療服務

### 第 954 條

- (1) 公務員或家屬如在香港以外地方接受任何牙科檢查或治療，一概不獲發還費用(下文第(2)段所述情況除外)。
- (2) 衛生署署長如信納申請發還的款項是用於緊急牙科治療並屬合理，可批准發還公務員在香港以外地方公幹期間支付的牙科服務費用。
- (3) 所有發還費用的申請必須附有收據以資證明，並須送交衛生署署長批准。
